Field Operations were immediately dispatched to the area, confirmed the leak, and isolated the valve to stop the leak on 4/13/2016 at 4:40 pm CST. Polar Midstream contacted a remediation contractor and they were dispatched to the site to recover any standing oil and begin remediating the site.

Wastes Disposal Location: Recovered waste and impacted soil will be hauled to a licensed disposal facility in the area.
