RE: Sign up for Electronic Death Registration

As a reminder, the North Dakota Department of Health will begin using our new Electronic Death Registration (EDR) module within our Electronic Vital Event Registration System (EVERS) beginning January 1, 2008. The new module, currently in the final stages of development will allow all North Dakota deaths and fetal deaths to be registered via a secure web-based Internet application. As one of the last states to develop these electronic registration systems, North Dakota has had the luxury of learning from the other states that have already traveled down this road. Because of that knowledge, we are hoping that our implementation of death registration will go smoothly and provide you and your staff with an efficient and time saving way to register deaths within our state.

We realize that not everyone is comfortable with electronic registration and some people are not real comfortable working with a computer. Because the system is new and there is some possible apprehension about using the system, we are going to do everything we can to make it easy to learn how to use the new system. First, beginning in late-November, my staff and I will be conducting live training sessions at regional locations around the state to make sure everyone involved with this process is properly trained. Second, the system itself is being designed so that the processes are simple and the chance of making a mistake is minimized. Third, our staff is going to be available to answer questions and deal with problems over the phone so that downtime is not an issue. Finally, we will be developing online video training sessions that will be on our website so that users can take the training whenever they have time in their busy schedules.

Now that the date is fast approaching, we need to get you and your staff signed up to become users of the new EDR. We are also going to make this process as easy as we can by providing step-by-step registration instructions so that you are ready to go in January. I have included a copy of the registration instructions and the EDR sign up form with this letter. Every new user will need to register separately. Don't delay in registering!! Selecting your ID and Password.

Your ID and password are required each time you login to EVERS.

Login ID Requirements

- Your Login ID must be at least 3 characters long.
- A suggested Login ID would be the first character of your first name followed by your last name.
- Your Login ID must be unique, if someone else has already signed up with your chosen Login ID you need to select a different Login ID.

Password Requirements

- Your password must be at least 6 characters long
- It must contain at least 1 upper case character
- It must contain at least 1 lower case character
- It must contain at least 1 number.

***Confirm Password:** Retype password for accuracy

Resetting your Password.

Security questions will be used to verify your identity and allow you to change your password.

Create Login

You will need to click this button to proceed. A confirmation e-mail will be sent to the e-mail address you provided. Please make sure the e-mail address you provided is valid.

Step 3, Confirm your Login ID and Password

1. Within the confirmation e-mail will be a web link. You must click on the link provided in the e-mail sent to you. (Again, please make sure the e-mail address you provided is valid.)
2. After clicking on the link, you will be sent to a confirmation page and asked to provide your password that you choose when you registered. Remember that passwords are case-sensitive.
3. After confirming your password, you will be taken to the State of North Dakota's main web page. Your state Login ID is ready! (If you do not get to this web page, your confirmation did not occur and you need to retry your password.)

Step 4, Request access to EVERS

1. Now that you have a registered State Login ID and password, your Login ID must now be configured for accessing the EVERS application.
2. Fax a completed User Authentication for EVERS form to Vital Records.
3. Another confirmation e-mail or a phone call will be made to your preferred method of communication to let you know that your access to the EVERS application is complete. **CONGRATULATIONS, YOU ARE READY TO REGISTER DEATHS!**
